Application Requirements

Please enclose all requested information with your application; incomplete applications cannot be considered.

- ✓ Maximum two (2) current photos of your ride or game
- ✓ Ride / game price list

Licence Fee - Amusement Areas

Exhibitor Passes

Exhibitor passes are issued for the sole purpose of staffing your stand. It is a criminal offence to sell or giveaway exhibitor passes for any other reason.

- Passes are allocated according to stand size
- Photo ID passes are a multiple entry pass valid for the duration of Ekka
- A single entry crew pass provides entry for one staff member for one day of the Ekka and will need to be presented with an authorisation card
- Additional exhibitor passes may be purchased

Presentation of Ride or Game

- All carnival sites require scrimming for back of house areas
- All rides must run for a minimum of two (2) minutes
- Game price and rules must be displayed at all times and you must adhere to the conditions of the current Games Code of Practice
- Each ride operator must be trained in the safety requirements of the ride or game and continually monitor the WHS standards and performance. Appropriate emergency response plans are to be in place

Noise Controls

- Noise limits apply and you are required to monitor noise. Exceeding the 85 dBA limit will result in prohibition notices being issued
- The RNA will impose the following conditions on any carnival operator exceeding the 85 dBA limit:
 - 1st offence: PA systems cut for one hour
 - 2nd offence: PA systems cut for one day
 - 3rd offence: Exhibitor's applications will not be accepted for the following year's Ekka
- Generators must be silenced and EPA approved
- Games and rides must have engineering controls in the form of compressors on audio equipment
- You must provide the necessary safety equipment, including hearing protection, for all employees

Cleaning

- No liquids can be poured down drains as this may result in Environmental Protection Agency prosecution
- Drip tray oil spill and bunds shall be placed to control hydraulic fuel, oil and discharges. Drop sheets must be placed under generators
- Carnival equipment including rides cannot be cleaned on site. It is illegal to use fire hose reels except in the case of fire. If required, water is to be obtained from taps by bucket only
